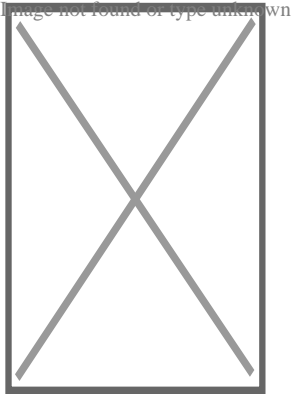
Jon Barnes
