Throughout her 28-year career, Cristy has taken 13 cases to trial. Below are two recent successes:

• [Obtained a defense verdict in 7-day jury trial involving allegations of medical malpractice.](#)

Case Summary: Cristy and another JSH attorney, Cory Tyszka, defended a physician against allegations of medical malpractice arising from an endoscopic procedure. The Plaintiff alleged that the procedure was not indicated and that Defendant was negligent in performing the procedure while Plaintiff remained on Plavix, causing Plaintiff to suffer a severe internal hemorrhage and associated complications. Defendant maintained that he met the standard of care in ordering the procedure and continuing Plaintiff's Plavix. Defendant further claimed that Plaintiff's alleged ongoing damages were caused by preexisting conditions. Plaintiff claimed approximately \$1,000,000 in damages due to pain and suffering, loss of consortium, loss of enjoyment of life, medical bills, and expenses.

Case Summary: Cristy obtained a defense verdict in favor of her client, an emergency room physician, in a wrongful death medical malpractice action. Plaintiff alleged the physician fell below the standard of care when she discharged Plaintiff's son after an 11-hour emergency room observation due to a methadone drug overdose. Plaintiff's son was discharged and sent home with his mother. Approximately 24 hours later, the son was found deceased. Defendant physician denied liability, indicating that before discharge, the son was ambulatory, had normal vital signs, participated in a mental health examination, and was answering questions and cooperating with hospital staff appropriately. Defendants argued that the son's death was not caused by the physician's actions or care in the emergency department. Plaintiffs asked the jury for \$1.2 million, and after deliberating for two hours, the jury returned a defense verdict.
